It can be used to remove tough acrylics, paints, lacquer sealers, latex paints, water based alkyd paints, and oil-based enamels on all types of substrates including concrete, masonry, brick, wood, steel, aluminum, and metal alloys. Classic Stripper is not sticky or messy like soy based strippers and saves on the cost for labor intensive mechanical stripping methods. After stripping, clean the surface with (CW305) Classic Eco-Etch Cleaner. Classic Stripper is available in 1 gallon jugs, 5 gallon pails and 55 gallon drums. It is recommended to test a small area before application.

## **SURFACE PREPARATION**

## ✓ READ SDS BEFORE HANDLING & APPLICATION

- ✓ Highly recommended to test a small inconspicuous area first.
- ✓ Always protect neighboring surfaces including wood, carpet, metal, landscaping and other non-masonry surfaces.
- ✓ Caution: Surface is slippery when wet.
- ✓ Before you start, be sure to wear rubber gloves & safety glasses

## **APPLICATION**

Classic Stripper is a ready to use product that is easy to apply using a roller or brush. The product should be applied at twice the thickness of the coating that is being removed. Do not let the stripper dry out after application. The coating is normally stripped in 4-6 minutes but it can be significantly longer for coatings with multiple layers. After stripping, the coating can be removed using a scraper, dry rag, steel wool, ShopVac, or power washer. Some floors may require you to apply two applications. Wash with a minimum 3,100 psi pressure washer. After using the stripper you must clean the surface with (CW305) Classic Eco-Etch Cleaner then power wash it off with a minimum of 2700 psi. Rinse surface with a water hose. Coverage rate will vary depending on the substrate and coating thickness. Use caution when walking on the floor as it will be slippery. Allow the surface to dry before applying a stain, sealer, or finish.

## LIMITATIONS

Classic Stripper is harmful to vinyl tile, linoleum, asphalt, plastics, rubber and synthetics. This product will remove old adhesive residue from tile, carpet and wood flooring.
