Classic Invisible Shield is a clear penetrating sealer & enhancer, single component low VOC, waterborne Sodium Methyl silicate sealer designed to be used over Classic Acid stains, pavers, concrete, stucco, granite, masonry, stone, brick, Spanish tile and some natural stone, provided the surface is properly prepared. It may be used for interior or exterior applications in a wide range of climates. Invisible Shield has excellent UV stability and will not yellow, chalk or peal. It is formulated primarily as a penetrating clear seal for applications over concrete restoration products and pool deck (not slippery) coatings where a low maintenance, easily cleanable surface is desired. It is environmentally safe and cleans easily with water. **New concrete must cure for 28 days before sealer is applied.**

## **PREPARATION**

- ✓ READ SDS BEFORE HANDLING & APPLICATION
- ✓ Highly recommended to test a small inconspicuous area first.
- ✓ TURN OFF SPRINKLERS FOR TWO DAYS PRIOR TO AND AFTER.
- ✓ Always protect neighboring surfaces including wood, carpet, metal, landscaping and other non-masonry surfaces.
- ✓ New concrete must cure for 28 days before sealer is apply.

## INSTALLATION

- 1. Prepare surface by carefully and thoroughly removing all traces of any foreign matter.
- 2. Apply first coat of Invisible Shield by a pump sprayer or roller.
- 3. Repeat step (2) for the second application.
- 4. Do not leave any excess product to puddle. White residue may appear on surface if not applied correctly. If sealer puddles, use a roller to remove excess.

Cure Time at 77°F: Dry to touch in 30 minutes, re-coat after 1 hour, light foot traffic after 2 hours and full cure in 48 hours.

NOTE: Standard application is two coats.
